2.1. Intended Purpose

The Smokeless XQuit App is a medical software to support smoking cessation. The current smoking habits are recorded in the app. Subsequently, the app supports smoking cessation by using methods of behavioural therapy.

4. Functionality

The medical app provides behavioural change therapy. Scientifically based concepts such as gamification, peer pressure and recognised drug-specific interventions are used for this purpose. The user goes through individual therapy tailored to their habits and smoking behaviour. Data on the smoking behaviour of the consumer is used for the individual therapy.

5. System Requirements

The Smokeless XQuit app supports:



- iOS 11 and Android Version 7.0 or higher
- A smartphone with at least 300 MB of free space
- A web browser that supports HTML5, JavaScript and CSS
- Bluetooth and internet connection
- Optional: Smokeless XQuit inhaler or other compatible Bluetooth inhalers

6. Application

The Smokeless XQuit app is aimed at users who intend to quit smoking.

7. Type and duration of application

The application duration includes an assessment phase and a smoking behaviour reduction programme and takes place over a period of 90 days.

After you have quit smoking, you can continue to use the app if you need to remain smoke-free.

8. Frequency of use

You should use the app at least once a day during the smoking reduction programme. You can continue to use the app if necessary to stay smoke free.

9. Contraindications (when not to use the app)

- Those under the age of 18
- Pregnant or breastfeeding women
- If you connect the app to a compatible inhaler, please take note of the possible contraindications of the combined device.

10. Safety Instructions

- If you have any health concerns or you feel unwell in any way, please consult your GP.
- If the app does not work properly, or if you feel uncomfortable or are in pain, stop using the app it immediately.
- If you connect the app to a compatible inhaler, ensure you follow the instructions and safety or warning notices for the combined device.

11. Side Effects

At this point in time, there are no known side effects from using the app.

12. Interactions
